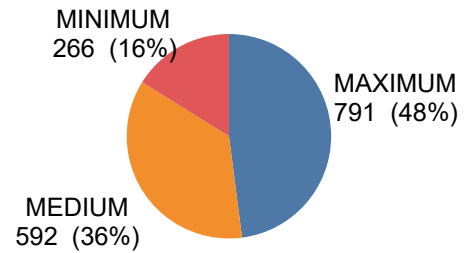

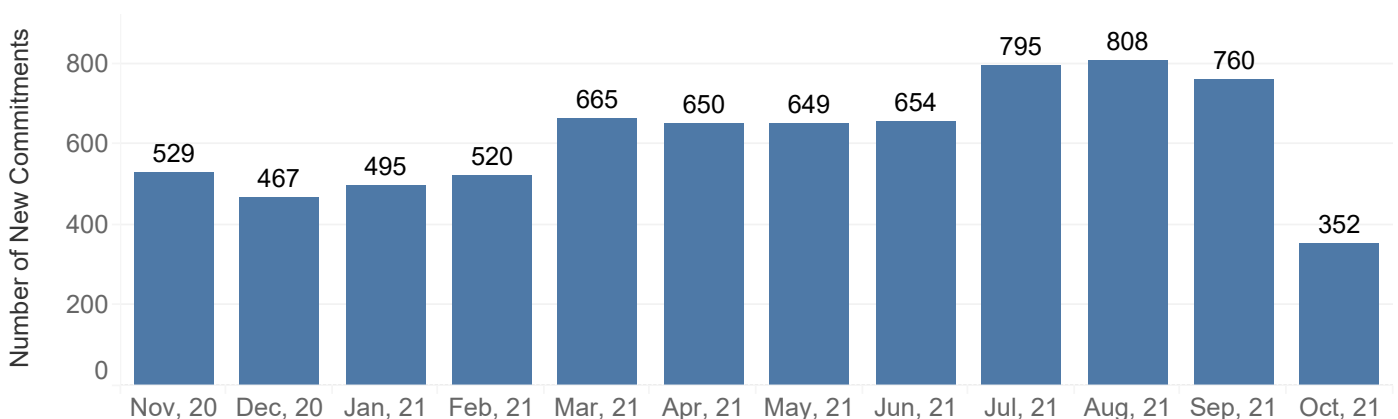

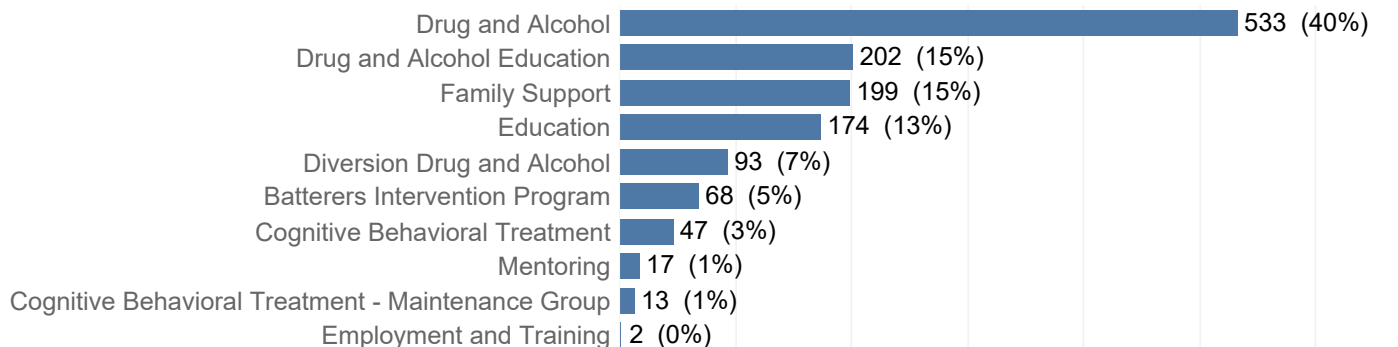

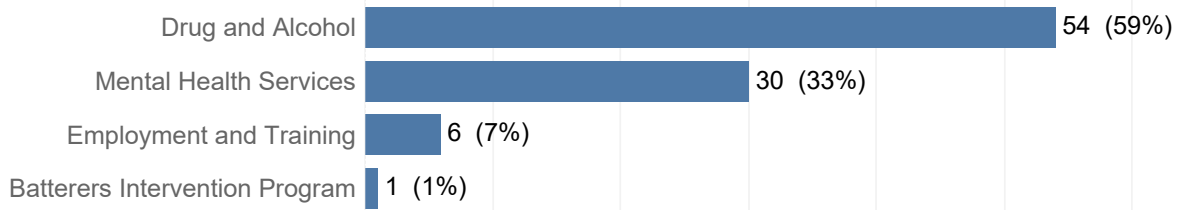

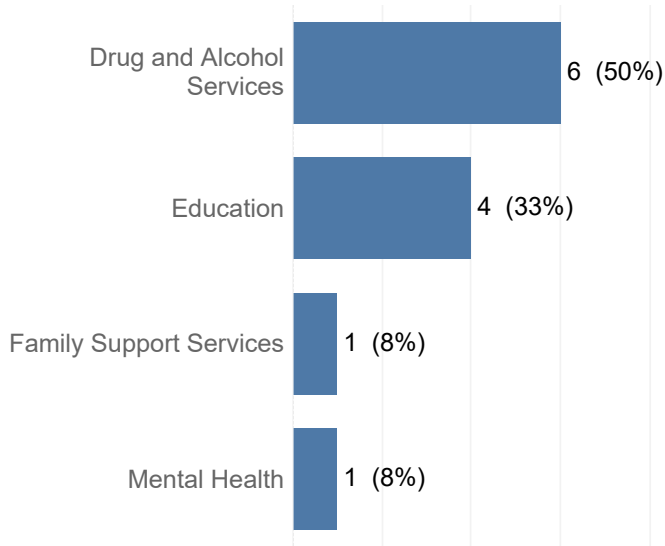

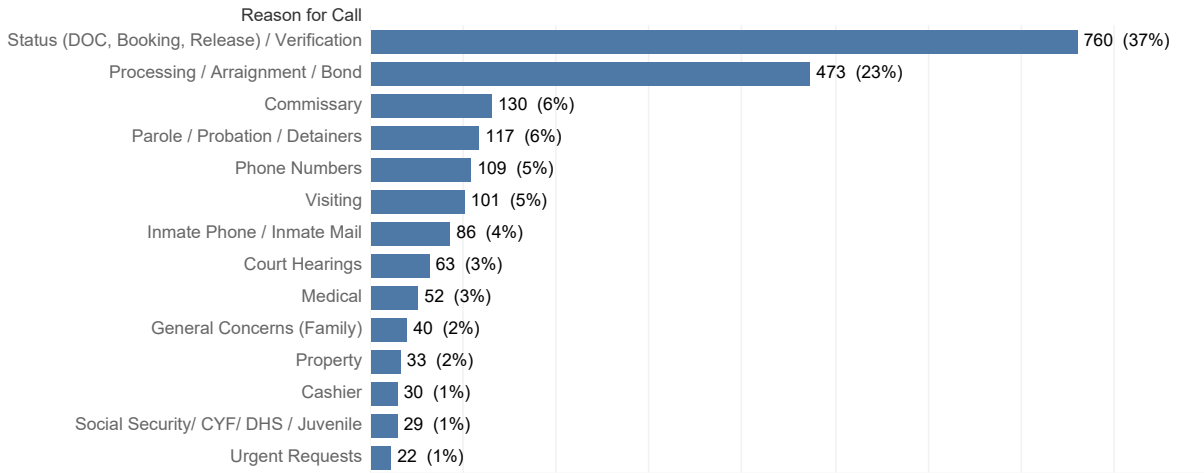

III. Visitation

Revocations to Jail include all returns to the Jail from Alternative Housing. Returns may occur due to health or medical reasons, court orders, or behavioral infractions. Walkaways from Alternative housing are inmates approved to attend outside activities such as a job, and they do not return to the facility by their curfew. This may include individuals who returned to the facility the same day or have been found and returned to ACJ directly. (9/16/2021 - 10/15/2021)
